traditional Chinese medicine, a very rare fact even though TCM have been applied for centuries in large numbers of population, and there are large numbers of medical doctors in China who have deep knowledge of western medicine and methodology. However, there are some issues should be addressed. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 2 figures. A total of 31 references are cited, including 9 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the CONSROT checklist form, the Clinical Trial Registration Statement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Yangtze River Pharmaceutical Group, Jiangsu Province, China. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors
