
To work on his/her research at your department, attached please find the letter of financial support issued by our office.

- Single, accompanied by 2 children: \$ 26,474 (in addition to \$8,292 for Medical Insurance)
- Married, accompanied by spouse: \$28,086 (in addition to \$8,316 for Medical Insurance)
- Married, accompanied by spouse and 1 child: \$ 29,698 (in addition to \$11,400 for Medical Insurance)
- Married, accompanied by spouse and 2 children: \$ 31,310 (in addition to \$14,448 for Medical Insurance)

**Research Fees:** What was agreed upon with the host advisor.

**Medical insurance:** Within the above figures (through the university insurance plan or our office insurance plan).

**Travel expenses:** The scholarship provides the scholar and his family with tickets to the USA and back to Egypt upon completion of the program.

As a holder of an Egyptian government scholarship, the above named scholar stays under our bureau's supervision, both financially and academically, until completion of the program. The scholarship requires the Scholar to be on J1 visa, hence kindly issue the DS 2019 Form for the scholar.
