The manuscript is very interesting but reviewer think that a careful revision is needed before it is acceptance. Minor revision is required. (3) Format: Four tables and two figures. Twenty-seven references were cited, including eleven references published in the last three years. No self-citation. 2 Language evaluation: A and B. The authors are native English speakers. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form. The author should provide all authors' signatures in copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was waived. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by Ministry of Higher Education, Egypt. (3) Corresponding author has not published articles in WJH.

Editorial Office Director: Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of liver transplantation is in the scope of WJH. Reviewer 03645171 showed that the manuscript is very interesting. However, the questions raised by the reviewers should be answered. There are 2 figures and 4 tables in the manuscript. Twenty-seven references were cited, including eleven references published in the last three years. No self-citation. 2 Language evaluation: I agree with the comments written by the science editor. The authors are from
