The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The reviewer pointed out this manuscript contained some very useful tips that had obviously been learnt over a number of years. This manuscript will be a useful addition to anyone wishing to undertake a mouse model liver transplant and will also make useful reading for those already carrying out this</p>	[Y]

type of research. However, there are a small number of grammatical/typographical errors but most importantly the figures need to be professionally drawn. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 40 references are cited, including 3 references published in the last 3 years. The authors need to update the references. There are no self-citations. We suggest the authors to cite their own research works in the review paper. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. CrossCheck detection showed a high similarity with other articles, our editorial policy states the overall similarity should be less than 30%, the overlapped section should be less than 5% in single papers, including author's own work. The authors need to rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Science and Technology Department of Jilin Province; the Finance Department of Jilin Province; and The First Hospital of Jilin University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1989 (under 45 years old). 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved
