The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study entails both novelty and interesting observations, with practical application in veterinary use, and potential benefits in</p>	[Y]

reducing the economic loss associated with cattle reproductive disorders. I have asked for minor revision, since there is a discrepancy in the total number of animals enrolled in the study as it appears in text (Materials and Methods section) and it is then reported in a Table summarizing the overall results. (3) Format: There are 8 figures and 1 table. A total of 43 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate was waived. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The ARRIVE Guidelines were uploaded. Institutional Animal Care and Use Committee Approval Form or Document was provided. No academic misconduct was found in the Bing search and the CrossCheck detection. 4 Supplementary comments: This is an invited manuscript. Without financial support. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "article highlight" section is missing, please add this section at the end of the main text. (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
