2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> Recommend for potential acceptance. 1 Scientific quality: The manuscript is a meta-analysis of pancreatic endoscopic ultrasound-guided fine needle aspiration. The topic is in the scope of WJG. (1) Classification: C and D. (2) Summary of the peer-review report: Reviewer thinks this manuscript is a valuable study to select a better cytology preparation. The topic is interesting. The paper</p>	[Y]

seems a bit "sloppy". The paper is very well written, interesting and easy to read. Major revision is required. (3) Format: Four tables and seven figures. Twenty-four references were cited, including nine references published in the last three years. No self-citation. 2 Language evaluation: 2B. Language editing certificate was provided by editage. 3 Academic norms and rules: The authors provided biostatistics review certificate and PRISMA 2009 Checklist. The authors signed copyright license agreement. The title is not consistent in conflict-of-interest disclosure form and F6 system. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by Natural Science Foundation of Zhejiang Province and Medical Health Science and Technology Project of Zhejiang Provincial Health Commission. (3) Corresponding author has not published articles in WJG.

**Editorial Office Director:** Recommend for potential acceptance. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of the paper is the liquid-based cytology and smears cytology in pancreatic endoscopic ultrasound-guided fine needle aspiration, and is within the scope of the WJG. The reviewers stated that this is a meta-analysis to compare the diagnostic accuracy of LBC and CS in the pancreatic lesions, which is interesting and valuable, but the authors need to revise the manuscript according the reviewers' suggestions. The questions raised by the reviewers should be

(3) Corresponding author has not published articles in BPG journals.</p> <p><b>Company Editor-in-Chief:</b> As a meta-analysis article, the manuscript was not written based on the author's own work, precluding its ability to meet the requirements of the World Journal of Gastroenterology. Thus, I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
