The topic is within the scope of the WJG. (1) <b>Classification:</b> Grade B, Grade C and Grade D; (2) <b>Summary of the Peer-Review Report:</b> Reviewer# 02702057 thinks this an interesting paper. The aim of this review</p>	[Y]

was to assess prevalence and development of osteoporosis and low bone mineral density, and its risk factors, in IBD patients. This systematic review of population-based studies is interesting and well written, innovative and well described. Moreover, minor revisions are needed to update the introduction (too poor) based on the current literature. Please add a sentence or improve the current ruling regarding the osteoporosis. Reviewer# 05189969 thinks this is a nice review of osteoporosis and IBD, though no meta-analysis was performed. However, there are some points need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 31 references are cited, including 8 references published in the last 3 years. There are no self-citations. We suggest the authors to cite their own research works in the review paper. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. A language editing certificate issued by RBPG was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1994 (under 45 years old). 5 Issues raised: (1) I found the
