2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the application of medial column classification in the treatment of intra-articular calcaneal fractures. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The author analyzed 91 patients' data in order to further improve the overall reduction effect and to explore the surgical options and individualized treatment of intra-articular calcaneal fractures. designed, and it will be useful to the clinician. However, the minor revision is needed; and (3) Format: There is 1 tables and 2 figures. A total of 30 references are cited, not including the references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided, however, the reviewer pointed out that the manuscript requires a minor editing, both the language and the writing style. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6
