2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a prospective study of the endoscopic full-thickness resection using an over-the-scope device. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The study has several novelties. However, the abstract needs to be shortened. The authors should clarify the situations where the over-the-scope device can be used, and define the criteria of mild</p>	[Y]

adverse events. The inconsistency with literature needs to be addressed. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 37 references are cited, including 16 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the Clinical Trial Registration Statement, and the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent where study participants signed to agree to the treatment, and the CONSORT 2010 statement filled with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Natural Science Foundation of China, Natural Science Foundation of Liaoning Province, and Outstanding Scientific Fund of Shengjing Hospital. The topic has not previously been published in the WJG. The corresponding author has published 5 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please

prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) please don’t include any \*, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01; (5) please write the “Conclusion” section at the end of the main text; (6) please provide an audio core tip file where the core tip content is recorded; and (7) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent where study participants signed to agree to the treatment, and the CONSORT 2010 statement that is filled with page numbers. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
