original prospective study on precancerous gastric lesions of WLE+NBI before and after H. pylori eradication. This is a good study with well conducted and could be benefit the clinical practice. However, there are some issues should be addressed. The reviewer suggests the authors discuss the limitation of this proposed HR-WLE with NBI endoscopy in the discussion part. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 49 references are cited, including 8 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form (file name: 55448-Copyright License Agreement), the Institutional Review Board Approval Form, the STROBE checklist, and the informed consent. The authors need to provide the Copyright License Agreement that signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the WJG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or
