Authors are native English speakers. 3 Academic norms and rules: The authors provided biostatistics review certificate and the ARRIVE Guidelines. The authors signed the conflict-of-interest disclosure form. The authors should provide all authors' signature in copyright license agreement. The authors declare that this study did not involve in human subjects. The institutional animal care and use committee approval form or document was provided. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJG.

Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of this manuscript is a basic study of immune responses to *H. muridarum* infection, and it is within the scope of the WJG. The reviewer 03009661 stated that the paper is very interesting and useful to DSS. The reviewer 03009411 pointed out that the relationship between infection and inflammatory bowel disease is a hot topic. The questions raised by the reviewers should be answered. 2. Language quality: 1A1B. The language certificate is not qualified. 3. Academic norms and rules: I have checked the
