convalescence phase? Each case should be assessed separately including the important points of CARE checklist. The reviewer#05378719 thinks the manuscript can be benefited from extensive revisions for grammar. The table should include the clinical features and the figures need description so that readers could understand. (3) Format: There are 2 figures and 1 table. A total of 16 references are cited, including 14 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade C and Grade C. A language editing certificate issued by CACTUS was provided. 3 Academic norms and rules: The authors did not provide the Conflict-of-Interest Disclosure Form and the CARE Checklist-2016. The authors signed the Copyright License Agreement and the Signed Informed Consent Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Emergency Special Project on Prevention and Treatment of COVID-19 with Traditional Chinese Medicine. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
