analyzing the liver function and clinical efficacy of patients with untreated and recurrent HCC. The inclusion criteria and exclusion criteria of primary HCC is reasonable, and very clear. Examinations are well performed. Results are interesting and well discussed; and (3) Format: There are 4 tables and 7 figures. A total of 48 references are cited, including 22 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form. Written and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Medical and health science and technology Foundation of Zhejiang Province and Ningbo Clinical Research Center for Digestive System Tumors. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please
