(1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer# 03262781 pointed out that in this study, the authors aimed to evaluate two different techniques for specimens EUS-guided specimens' collection: EUS-FNA cytology and</p>	[Y]

	<p>EUS-FNB histology. However, there are some points need to be addressed in the manuscript. Such as: (1) The abstract seems too long; (2) the authors should cite some papers of pancreatic vascularized lesions and the aim of the study should be clarified in the “introduction” section; (3) the authors should add a table to compare the demographic, technical characteristics and lesions features of the 3 groups; and (3) Format: There are 2 tables. A total of 20 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. This manuscript is from United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to complete the STROBE Statement checklist file. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Center for Advancing Translational Sciences through UCLA CTSI Grant UL1TR001881-01. The topic has not previously been published in the WJGE. The corresponding author has published 1 article in the WJGE. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
