The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors evaluated the bowel function and quality of life of</p>	[Y]

right-sided colon cancer patients after minimally invasive colectomy with D3 lymphadenectomy, which is meaningful. However, there are some issues should be addressed. The cases in the study was limited. And it was reported in the manuscript, about 35-40% of the patients received chemotherapy, the chemotherapeutic regiments and its influence on bowel function should be described and analyzed. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 23 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. Although the authors provided the language editing certificate, the language needs to be further improved. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using

	<p>PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
