(1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors recommend embryoid body-based 3D suspension culture with multiple cells co-culture as a comprehensive approach, based on others and their own experiences, which is concise and well-written and will be very</p>	[Y]

useful for the field and is timely critical. However, the questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 69 references are cited, including 48 references published in the last 3 years. There are 9 self-citations. The authors had published 5 articles in BPG journals. 2 Language evaluation: Classification: Grade A. The language editing certificate was provided by editage. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJSC. 5 Issues raised: The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
