HAIC was an effective and safe treatment for patients with advanced HCC with portal vein invasion or extrahepatic metastasis. While the result of this clinical study was negative, the study design was excellent, and manuscript was quite well written. To make the article more persuasive and fruitful, the authors need to discuss the following issue. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 32 references are cited, including 8 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Rude Health Consulting was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, CONSORT Checklist Form, Clinical Trial Registration Statement, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Sanofi. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. The first author was born in 1977 (under 45 years old). 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.
