references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and B. A language editing certificate by Wordvice was provided. 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form was not properly provided. Copyright License Agreement was provided. Signed Informed Consent Form(s) or Document(s) and Biostatistics Review Certificate were uploaded. The STROBE Statement was uploaded. No academic misconduct was found in the Bing search and the similar index is 31% in the CrossCheck detection, the repeated sentences should be rephrased. 4 Supplementary comments: This is an invited manuscript. Supported by the National Research Foundation of Korea, NRF-2018R1D1A1B07041091, NRF-2019S1A5A8034211. The topic has not previously been published in the WJP. 5 Issues raised: (1) Please provide original picture which could be editable. (2) Please add "article highlight" section. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
