They clarify the possible reasons that why no liver failure was encountered after simultaneous TACE and PVE. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 26 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form and the Informed Consent Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Medical Health Science and Technology Project of the Zhejiang Provincial Health Commission. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words.
