The reviewer thinks this article is useful and valuable to anesthesiologists, endoscopists, or registered nurses when they consider an appropriate sedative for elective endoscopies in patients with cirrhosis. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 7 figures. A total of 48 references are cited, including 13 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors provide a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. Please rephrase these repeated sentences. The authors have published the “abstract” (<a href="https://www.thieme-connect.de/products/ejournals/abstract/10.1055/s-0040-1704586">https://www.thieme-connect.de/products/ejournals/abstract/10.1055/s-0040-1704586</a>). 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has published 7 articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using</p>
