The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Reviewer#03256583 thinks this is a very current concept, in particular with the COVID pandemic as all of us are trying to use/install telehealth platforms and communicate with our patients. This is a good review, but there are some points need</p>	[ Y]

to be addressed. The authors need to check the spelling, and to add some figures or tables. The questions raised by the reviewers should be answered; and (3) Format: There are no any tables or figures. The authors must add some figure or tables to show the key points. A total of 116 references are cited, including 58 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) The authors need to add some figures or tables; and (2) The authors need to provide the Copyright License Agreement signed by all authors. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
