authors need to discuss the limitations of this study. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 51 references are cited, including 16 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by NES was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and the Institutional Review Board Approval Form. The authors need to provide the Copyright License Agreement signed by all authors, and the Institutional Animal Care and Use Committee Approval Form. The authors need to fill out the ARRIVE form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text
