designed and described. The results are satisfactorily exposed and discussed. The literature is properly cited. However, the Figures 6-7 should be revised according to the comment, some typos and errors should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 8 figures. A total of 44 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade A and Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 2 national grants and 4 provincial grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The "Author Contributions" section is missing.
