resection margins in one case and hyperplastic polyps in three cases. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 2 figures. A total of 10 references are cited, including 6 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chonnam National University Hospital Biomedical Research Institute. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
