**BACKGROUND**

Pneumonia of uncertain cause has been reported in Wuhan, China since the beginning of early December 2019. In early January 2020, a novel strain of  $\beta$ -coronavirus was identified by the Chinese Center for Disease Control and Prevention (CDC) from the pharyngeal swab specimens of patients, which was recently named SARS-CoV-2. There is evidence of human-to-human transmission and familial cluster outbreak of SARS-CoV-2 infection. The World Health Organization (WHO) recently declared the SARS-CoV-2 epidemic a global health emergency. As of February 17, 2020, 71329 Laboratory-confirmed cases (in 25 countries, including the United States and Germany) have been reported globally. Other than its rapid transmission, the epidemiological and clinical characteristics of coronavirus disease (COVID-19) remain unclear.
