by the Reviewer 00681914. Reviewer 00504019 thought their evidence is not so solid: There is no any gastrointestinal symptoms described in the context. The authors need to add more data on clinical manifestations of gastrointestinal symptoms; and (3) Format: 1 figure. 6 references are cited, including 3 references published in the last 3 years. No self-citations. 2 Language evaluation: Classification: A, B and B. Authors are all Americans. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The corresponding author has previously published one article in the WJD. 5 Issues raised: (1) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditionally accepted.

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is a case of COVID-19 presenting with gastrointestinal symptoms, and is within the scope of the WJV. (1) Classification: Grade A, Grade B, and Grade E; (2)

	<p>Summary of the Peer-Review Report: Reviewer#00504271 summarized this is an actual report about the COVID-19. The reviewer suggests the intravenous ceftriaxone and azithromycin for 7 days doses should be given more exactly as a recent report on 204 patients positive for COVID-19 in Hubei. Reviewer#00681914 pointed out this manuscript described a case of gastrointestinal problem without respiratory symptom. It is interesting and should be shared by physicians. Reviewer#00504019 pointed out this Letter present a case of COVID-19 of a 83 years old woman who presented with only gastrointestinal symptoms without respiratory complaints. Although the authors state their case underscores the urgent need for further studies to understand the role of the gastrointestinal system in 2019 SARS-CoV-2 transmission and COVID-19 pathogenesis, their evidence is not so solid. The authors need to revise the manuscript according to the reviewer's comments; and (3) Format: There is 1 figure. A total of 6 references are cited, including 3 references published in the last 3 years. The authors need to add more references about the COVID-19. There are no self-citations. 2 Language evaluation: I agree with the comments made by the science editor. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, and Copyright License Agreement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study is without financial</p>

The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name. The authors need to revise the manuscript according to the reviewers and Editor-in-Chief's comments (Thank you for your email , actually, it is a very interesting case proceed for submission, but there are some comments to be considered: 1) where the blood picture? is there leucocytosis? is there lymphopnea (you know that lymphopnea with normal leucocytic count is characteristic for COVID-19; 2-)Where the result of PCR for COVID-19 before discharge.? 3) Please try to include considered these points during submission). 6 Recommendation: Conditionally accepted after major revision</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
