2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the study on the efficacy and safety of S-1Maintenance therapy in advanced NSCLC patients. The topic is within the scope of the WJCC. (1) Classification: Three Grades B; (2) Summary of the Peer-Review Report: The study deals with an interesting theme, investigating the efficacy and safety of S-1 maintenance therapy in patients with advanced non-small cell lung cancer. The patients included in the study were divided into the S-1</p>	[Y]

group and the gemcitabine group by random digital table method, and their number was considerable. The clinical efficacy and quality of life of the patients after treatment in the two groups were evaluated. The discussion section gave emphasis to the new contribution of the study in its field. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 20 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
