2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of P-Rex1 in the diagnostic for hepatocellular carcinoma. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors explore the expression of P-Rex1 in HCC, and further evaluate its potential application in the diagnostic and predictive prognosis for HCC, especially in the diagnosis in HBV-related patients. The idea is very good. The study</p>	[Y]

is well-designed. The manuscript was well, concisely and coherently organized. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 6 figures. A total of 35 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by YHYSCI was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
