association between PNPLA3 and TM6SF2 genotypes and clinical parameters and liver histological features of nonalcoholic fatty liver disease (NAFLD). This is helpful for understanding genetic risk of NAFLD. However, some questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 49 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language was edited by a professional translator. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the written informed consent, and STROBE Statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported 1 grant. The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (8) The "Article Highlights" section is missing.
