2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a clinical and translational research of the HBV-associated acute-on-chronic liver failure. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This manuscript focuses on the nutritional risk assessment in hepatitis B patients, investigating different surrogate markers. This is an interesting and well-written manuscript however, the authors tend to overcomplicate with the</p>	[ Y]

presentation of numerous results, making it difficult for the reader to follow the main idea. The reviewer suggests authors focus on the most important results and try to modify the “Methods” and “Results” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 6 figures. A total of 33 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the written informed consent, and the Clinical Trial Registration Statement. The authors need to provide the CONSORT 2010 form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Tianjin Science and Technology Project; and the National Major Science and Technology Projects in the 13th Five-Year Plan. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 52494. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;</p> <p>(3) I found the authors did not add the PMID and DOI in the reference list. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text.
