2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a basic study of the Crohn's disease. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The reviewer thinks this is an interesting study with a consistent number of data. However, my major concern regards the</p>	[Y]

morphological method and findings. The images obtained with both optical and electronic microscopes do not allow to distinguish the morphological details described in the results. The authors need to modify the figures according to the reviewer's comments. The discussion part should be rewritten in order to highlight the comparison of the results with the other observations. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures and 1 table. A total of 57 references are cited, including 18 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, Institutional Animal Care and Use Committee Approval Form, and ARRIVE checklist form. This manuscript is not involved in human materials, the Institutional Review Board Approval Form is not applicable. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Sciences Foundation of China; Program of Shanghai Academic Research Leader; Three-year Action Plan Project of Shanghai Traditional Chinese Medicine Development; Chinese Medicine Inheritance and Innovation "100 Million" Talent Project; and the Shanghai Rising-Star Program. The topic has not

previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
