“method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 24 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Thirteen Five-year Great Science and Technology Project of China; and National Twelve Five-year Great Science and Technology Project of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section. Please write the “article
