The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C, Grade C and Grade E; (2) Summary of the Peer-Review Report: The manuscript presents the case of an unusual hepatic tumor. The clinical course is well described. This case may help other clinicians</p>	[Y]

to consider lymphangioma as a possible differential diagnosis of hepatic lesions. The introduction section is poor and there are no data regarding possible ethiopathogenic mechanisms underlying the disease. The discussion is quite poor as well. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 32 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and the informed consent. The authors need to provide the Copyright License Agreement signed by all authors and fill out the CARE checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; Foundation for the Development of Science and Technology of Hubei Province; and Foundation of Tongji hospital, Tongji medical Tongji Medical College, Huazhong University of Science and Technology, China. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
