2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the comparison between CT and MRI in clinical diagnosis and treatment of tibial platform fractures. The topic is within the scope of the WJCC. (1) Classification: Two Grades B and Grade C; (2) Summary of the Peer-Review Report: the study is very well designed and the results are very interesting.</p>	[Y]

The sample size is enough and methods are very clear. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 20 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: 3 Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. The re-review is required.
