2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the intrahepatic bile duct stones. The topic is within the scope of the WJG. (1) Classification: Grade A, Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: This study is very interesting. The author proposed a modified percutaneous transhepatic papillary balloon dilation procedure. Although the sample size is not so large, the results are interesting</p>	[Y]

and important. However, there are some issues should be addressed. The manuscript required a minor revision, both for the language and the format. The methods are described in detail. Inclusion and exclusion criteria are clear. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 29 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and written informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 5%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Natural Science Foundation of Shandong Province and National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I

found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
