The topic is within the scope of the WJG. (1) Classification: Grade B and Grade E; (2) Summary of the Peer-Review Report: The paper is interesting and presents a new method for predicting survival for gastric cancer. the authors need to give some indications for the practical application of the model. The uploaded paper does not include Table 1, the patient background and stage cannot be determined. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 18 references are cited, including 12 references published in the last 3 years. There are 5 self-citations. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by CureEdit was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The authors need to provide the Biostatistics Review Certificate. No animals are involved in the study. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Liaoning S&T project; Shenyang Young and Middle-Aged Scientific & Technological Innovation Talents Support Plan; and National Key Research and Development Program. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant
