(1) Classification: Three Grades B; (2) Summary of the Peer-Review Report: The authors report an interesting case of brachytherapy treatment in hilar cholangiocarcinoma. concise and illustrative manner, and patient follow-up for an extended period of time; and (3) Format: There are 3 figures. A total of 12 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade C. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent was wrongly submitted. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Key Scientific Research Projects of Higer Education Institutions in Henan Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C. Correction: scientific classification: B, B, B, and D.</p> <p>Reviewer 00054672: The case is presented clearly, however the manuscript is lacking a proper and in-depth discussion. The manuscript would benefit from English editing.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
