The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors report a case of metastasis of esophageal squamous cell carcinoma to the thyroid grand. This is rare case and thus the readers will be interested in this report. However, the questions raised by the reviewer should</p>	[Y]

be answered; and (3) Format: There are 4 figures. A total of 15 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and the Written informed consent. The Copyright License Agreement lacks of the signature in handwritten. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
