2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a systematic review of the predictors of severe and critical COVID-19. The topic is within the scope of the WJCID. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This was a systematic review of the predictors of COVID-19, but only 5 articles were retained for the review, and all have come from China, so the non-overlap of the samples' participants should be stated; and (3) Format: There are 3 tables and 1 figure. A total of 23 references are</p>	[Y]

cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors stated that the language was edited by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and PRISMA 2009 Checklist. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCID. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
