Specific Comments to Authors:

1. Line 59: upwardly displaced L4/5 LDHs and provide an example of the resorption: Should be spontaneous resorption.

Reply: We revised the manuscript according to the comments (line 61).

2. The data from references 3 and 18 should be revised

Reply:

References 3: We calculated 96% (line 110) of the incidence of resorption based on the data reported by the authors: “of 505 participants, 19 did not show disc resorption, while 486 did”. The authors reported: “The average time interval between baseline and followup MRI was 341.38 ± 306.83 days”. We revised the average follow-up time at line 110.

References 18: The authors reported “Our meta-analysis showed that the overall incidence of spontaneous resorption after LDH was 66.66% (95% CI 55.12% – 78.21%)”. We revised our manuscript (line 116, 117).

3. Line 133 should be Macki etal 25 not Mohamed

Reply: We revised the name of the author (line 134).

4. The English of the manuscript needs revision.

Reply: We have improved the phrasing of sentences and the readability of the manuscript, and our revised manuscript manuscript has been edited by American Journal Experts. Please see English editing certificate.
