The topic is within the scope of the WJGE. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is a very interesting and well-presented case report highlighting the usefulness of endocytoscopy for the</p>	[Y]

diagnosis of deeply invasive (colorectal) cancer. However, there are some issues should be addressed. Potential / limitation of the method should be discussed. An additional figure of histopathology would be a good addition. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 18 references are cited, including 8 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, written informed consent, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. 5 Issues raised: Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
