Summary of the Peer-Review Report: The manuscript studied the sensitivity profile of group B streptococcus (GBS) from 38 pregnant women, its result is significant to guide obstetricians for choosing antibiotics for those pregnant women allergic to the first line antibiotics. However, some new references should be added. The English should be revised. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 20 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade C, and Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJOG. 5 Issues raised: (1) The language classification is Grade C. Please provide the original figure documents. The questions raised by the reviewers should be answered. The authors need to update the references. I have changed the manuscript type “clinical and translational research” to “retrospective study”. There are no figures.
