The BBS Score before the operation can be added as a control. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 60 references are cited, including 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the CONSORT checklist form, and informed consent. The authors need to provide the Clinical Trial Registration Statement. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 9%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has published 5 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or
