educational value. The aims are stated clearly. The title is informative and relevant. The research question and questionnaire items are clearly outlined. The study methods are valid and reliable. There are enough details provided and the data is presented in an appropriate way. Statistics and Tables are relevant and clearly presented. The conclusions answer the aim of the study. The conclusions are supported by references and own results. However, there are some points should to be addressed. The authors need to clarify how to select the patients, the tables should be shortened to reflect the most important data. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 36 references are cited, including 7 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. The authors provided a personal language certificate.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form is not applicable. Written informed consent was waived. The authors need to fill out the STROBE form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Philip Morris Products SA. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the
