The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 4 figures. A total of 42 references are cited, including 14 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the PRISMA Checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Health Commission of Hubei Province; Natural Science Foundation of Hubei Province; and the Science and Technology Bureau of Shihezi. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure
