rate of the pandemic calls for global shared knowledge among professionals and non-professional health workers and so the article is commendable, the article further confirmed the roles of physician policy implementers on the three-level screening strategy by Gao et al., and an innovative self-made gastroscope isolation mask. Reviewer# 04031726 pointed out there were some points need to be addressed. The authors did not even have the respect to format the manuscript according to the journal's rules. The article is completely badly formatted. Reviewer# 03028174 pointed out this study was aimed to report the authors' experience for management of an endoscopy center during the outbreak of COVID-19. The authors need to discuss the factors that influence the outcome of this management. Finally, please recommend the readers "How to apply this knowledge for routine clinical practice in the community hospitals? The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 10 references are cited, including 9 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade C, and Grade C. Although the authors has provided the language editing certificate of MedSci, the language needs to be further improved. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study

The corresponding author has published 5 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
