A clarification about autoimmune pancreatitis and recent acquired informations about physiopathology, diagnosis and treatment are useful for experts and non-experts. authors need to supply some imaging (CT scan/MRI) and histopathology. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 115 references are cited, including 20 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was Grade C.
