(1) Classification: Grade B; (2) Summary of the Peer-Review Report: Reviewer#03303427 summarized the authors explored the relationship between IRS-1 expression, its associations</p>	[Y]

with the apoptotic and proliferation tumor markers and clinicopathological features in human CRC. However, there are some issues should to be addressed. The authors should describe the inclusion criteria of CRC patients. Maybe this study is not profound enough. It will be better if there are some researches about the mechanism and deeper relationships among IRS-1 and apoptotic markers. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 32 references are cited, including 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) I found the authors did not write the “article highlight” section. Please write the “article

	<p>highlights” section at the end of the main text; and (3) the authors need to revise the “abstract” section (structured abstract). 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
