The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors discuss the treatment modalities of a rare complication of chronic pancreatitis developed in children. However, there are some issues should be</p>	[Y]

	<p>addressed. The number of cases is very small and making statistically significant conclusions and recommendations is impossible. They also conclude that there was no difference in the hospital stay between the two treatment modalities without discussing the reasons. The authors need to add the complications of surgery and endoscopy, discuss the technical details of surgical interventions and endoscopic procedures. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 56 references are cited, including 15 references published in the last 3 years. There are no self-citations.</p> <p>2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Edanz was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the “article highlight”</p>
