(1) Classification: Grade C; (2) Summary of the Peer-Review Report: It would be interesting to know the radiological signs, when present, of COVID-19 pneumonia, mainly if complicated by an ARDS. Some points of differential diagnosis with other acute pulmonary diseases are invited. The incidence of</p>	[Y]

pulmonary embolism can be discussed; and (3) Format: There are 1 table and 9 figures. A total of 61 references are cited, including 55 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Guiyang Science and Technology Project. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
